

REGULATIONS OF THE FUNDACJA WORLD WEBSITE

§ 1 Introductory provisions

(1) The Rules of Procedure shall determine the rules of use of the Fundacja World website available at the domain address <http://fundacjaworld.pl/>.

(2) The rules of use of the Service are made available free of charge to each User at the Internet address <https://fundacjaworld.pl/regulamin.pdf> in a way that allows you to download, record and print the Regulations.

(3) The Rules and Regulations shall be applicable to all Services available on the Site.

(4) The provisions of the Regulations, together with the provisions of the law in force in the territory of the Republic of Poland, shall exclusively determine the rights and obligations of the Users of the Site, as well as the rights, obligations and responsibilities of the entities having the rights to operate and administer the Services made available through the Site.

§ 2 Using the Service

(1) The purpose of the Service is to inform Users about the activities of the Foundation and to promote it.

(2) Using the window on the home page of the domain, Users can make a donation through the Service to support the Foundation.

(3) Using the "Contact Us" tab, Users can send an inquiry to the Foundation regarding the possibility of obtaining support from the Foundation via e-mail or get in touch by phone at the telephone number indicated there.

§ 3 The rules of making payments to the Foundation

1 The Foundation provides an up-to-date list of methods for making payments to the Foundation in the Service.

(2) Financial support for the Foundation can be made using one of the following methods: a) through the PayU/BLIK mobile payment system- made available through the window on the home page of the domain b) through the PayPal virtual purse- made available through the window on the home page c) by making a payment to the specified bank account number (one-time or recurring, through a standing order).

(3) In the case of choosing the method indicated in item 2 letters a and b above, the User may choose the option of one-time or recurring support. After providing Personal Data and the amount of support and clicking "Contribute", the User is redirected to the Payment Operator's website. Finalization of the transaction requires acceptance of the Operator's Terms and Conditions.

(4) A recurring payment is in the nature of a monthly donation automatically transferred by card.

(5) In the case of choosing a recurring payment, after verifying the credit or debit card details, the Foundation will receive the first donation and the User will receive an email confirming the correct initiation of the recurring payment.

(6) Subsequent recurring payments will be charged to the card by the 10th calendar day of each month.

§ 4 Violation of the Regulations by the User.

(1) It is forbidden to use the Service for illegal purposes, inconsistent with the Regulations or violating the rights of others.

2. Regardless of the consequences of violations of common law, the Foundation considers it unacceptable: a) sending pornographic content; b) practicing commercial, advertising, promotional activities; c) sending spam and unsolicited commercial information; d) using Personal Data of other Users for purposes not related to the functioning of the Service; e) taking any actions through which a person or entity carrying them out in an unauthorized manner influences or attempts to influence Users, act to their detriment, to the detriment of the Foundation or other third parties; f) taking any actions that may threaten the security or integrity of the network and telecommunication services; g) any Materials made available on the Service that violate the copyright or related rights of any third parties.

3. The User is authorized to download or print the contents of the Service for private purposes only. The content of the Service may not be copied, reproduced or used in any other way. The User is not authorized to modify or redistribute the content of the Service, or reproduce, link, frame or deep link to that content on any other website without the express written consent of the Foundation.

(4) If a User's violation of the Terms of Service has caused damage to the Foundation, in particular by limiting in whole or in part the accessibility of the Service to other Users, the Foundation may pursue legal action against such User.

§ 5 Personal Data of Users

The rules for the processing of Users' Personal Data are regulated in the Privacy Policy.

§ 6 Copyright and related rights 1.

(1) Copyright and related rights to the Service as a whole and its individual parts, graphic elements, words or music, in particular to the Foundation's logo, as well as the rights to the composition of these elements and their arrangement on the website belong to the Foundation.

(2) Materials that are works as defined by copyright law or objects of related rights are protected under the Law on Copyright and Related Rights without the need for a separate reservation, in particular, without the need to make any statements by the Foundation or the User introducing them to the Service.

(3) The Foundation owns the copyright and related rights to the content and Materials entered by the Foundation and made available in the Service.

4th It is forbidden, without the consent of the Foundation expressed in writing under pain of invalidity: to copy, disseminate or any other use in whole or in fragments of information, Materials or other content presented in the Service, with the exception of cases provided for by mandatory provisions of common law.

§ 10 Complaints

(1) Complaints about the operation of the Website and individual Services may be lodged by the User via e-mail: contact@fundacjaworld.pl.

(2) In the complaint, the User should indicate the subject of the complaint, in particular describe the Service to which the complaint relates, as well as the circumstances justifying the complaint and

provide data enabling contact with the User (e.g.: mailing address, contact telephone number or e-mail address).

(3) Complaints will be considered by the Foundation immediately, no later than 14 days from the date of filing the complaint.

(4) In the event that the complaint does not contain the data enabling the contact with the User, the Foundation is entitled to leave the complaint without consideration.

(5) Complaints about payment services should be addressed directly to the Payment Operator or GSM operator. Complaints about payment services addressed to the Foundation, will be immediately forwarded by the Foundation to the appropriate entity which is responsible for handling the complaint, of which the User will be informed by the Foundation.

(6) The lodging of a claim by a User, as well as its non-recognition or leaving it unprocessed by the Foundation, does not affect the User's right to pursue claims in court in accordance with applicable law.

§ 11 Principles of validity and amendments to the Regulations

1st These Regulations come into effect as of

2. the Foundation may from time to time make changes to these Regulations. The amendments to the Regulations planned by the Foundation, together with the date of their entry into force, will be made available to the Users in the same way in which these Regulations were made available.

(3) A User who is a party to an agreement concluded for an indefinite period of time, and who does not accept the proposed change to the Regulations, may terminate the agreement with a notice period of one month from the last day of the month in which the proposed changes to the Regulations were made available to the User. The termination may be effected by sending a relevant statement of the User to the postal address of the Foundation or to the e-mail address contact@fundacjaworld.pl.

§ 12 Final provisions

(1) These Regulations, as well as agreements concluded on their basis, are governed by Polish law and will be interpreted in accordance with this law.

(2) Any information about violations of these Regulations by the User should be addressed to contact@fundacjaworld.pl.
